Fulbright Canada 20th Anniversary Alumni Contest

In recognition of Fulbright Canada's 20th anniversary, we are inviting all Fulbright Alumni to enter our **20th Anniversary Alumni Contest**. You could win an all expenses paid trip to Ottawa for our **20th Anniversary GALA in September!** The challenge is to tell us about your Fulbright experience in

**an Essay (1000 word max),
a Video (5 minute max),
or, a Visual Art Project.**

You could also win one of TWO \$500 travel vouchers, or one of THREE \$200 travel vouchers. All entrants will receive a Fulbright Canada 20th Anniversary t-shirt. (See reverse for details.)



The theme for your entry should be **'My Fulbright Experience'**. You are encouraged to take into consideration the following questions: *What was/were the highlight(s) of your Fulbright experience? What surprised you about your host country? What else was going on in the Canada-US relationship at that time, and did it have an impact on your experience? What is the value of academic exchange? How did your Fulbright experience affect your academic and/or career path?*

Rules & Regulations

1. You may elect to submit an entry alone, or work with a group of alumni (maximum of three) to create your combined entry.
2. Your entry must be submitted no later than **Friday, June 25**.
3. All entries must include the name and contact information (including phone number, email, and mailing address) for all of the alumni involved in the entry.
4. Essays must be submitted electronically to alumnicontest@fulbright.ca.
5. Videos must be uploaded to a secure location. (Details to follow.)
6. Visual Art projects must be submitted by mail to:

7. The selection committee will review the entries and select one grand prize winner, two second place entries, and three third place entries. The winners will be announced at the end of July.
8. The alumnus/alumni that submit(s) the **Grand Prize winning** entry will receive one 'all expenses paid trip' to Ottawa for the Fulbright Canada 20th Anniversary Gala on September 23, 2010. (For team entries, up to three alumni will be eligible.) The Grand Prize winner(s) will be provided with an economy flight or train ticket from any location in Canada or the United States. Tickets will be purchased by Fulbright Canada in consultation with the prize winner(s). The Grand Prize winner(s) will be provided with two nights accommodation at the Lord Elgin Hotel (www.lordelginhotel.ca). The Grand Prize also includes local transport to/from the airport/train station, transport to/from the gala in Ottawa, and meals while in Ottawa. The winning entry will be featured on the Fulbright Canada (and partner) websites, in Fulbright Canada (and partner) publications, as well as being featured prominently at the gala.
9. Two entries will be chosen to receive second place prizes. The winners will be reimbursed up to \$500 CAD toward their travel to Ottawa for the gala on September 23, 2010. (For team entries, every member of the team will be eligible for a reimbursement of up to \$500 CAD, up to a maximum of \$1500 per team.) The payment will be made only against eligible receipts submitted prior to October 31, 2010. Eligible receipts include travel to and from Ottawa, local transport to/from the airport/train station, transport to/from the gala in Ottawa, accommodation in Ottawa for up to two nights, and meals while in Ottawa. Some exceptions may apply.
10. Three entries will be chosen to receive third place prizes. The winners will be reimbursed up to \$200 CAD toward their travel to Ottawa for the gala on September 23, 2010. (For team entries, every member of the team will be eligible for a reimbursement of up to \$200 CAD, up to a maximum of \$600 per team.) The payment will be made only against eligible receipts submitted prior to October 31, 2010. Eligible receipts include travel to and from Ottawa, local transport to/from the airport/train station, transport to/from the gala in Ottawa, accommodation in Ottawa for up to two nights, and meals while in Ottawa. Some exceptions may apply.
11. All entrants will receive, by mail, a special edition Fulbright Canada 20th Anniversary T-Shirt.
12. For all prizes, non-eligible expenses include alcohol, tobacco, and gifts.
13. Prizes are non-negotiable, non-transferable, and not redeemable for cash.
